
Top 4 Things You Should Know About

1. Your contributions count




What you don't contribute gets carried over.

For example, in 2018 the contribution limit was \$5,500. If only \$4,500 was contributed, then the unused \$1,000 can be carried over to 2019.



If you take money out, you get that contribution room back the following year.

Let's say you contributed \$5,500 early in 2018 and then withdrew \$1,000 later in the year. You'd have that \$1,000 contribution room back in 2019.
